[ix] To provide accommodation and food facilities to meritorious students.

[x] To undertake any other work this would be helpful for poor students and bring out overall development thereby achieving the desired cultural change

6. MANAGEMENT:

[i] The trustees managed by a Governing body called "Board of Trustees" constituted by four trustees. Mr. A.J Suresh, the founder trustee shall be the managing trustee and will work with one of the another three trustees for conducting day to day affairs to achieve the aims and objectives of the Trust.

[ii] The Trustees have got powers to nominate such number of persons as associate trustees on such terms and conditions upon his / their taking oath to carry out the objectives of the Trust diligently and with total dedication with powers to give advice to the Trustees and generally support the objectives/cause of the Trust as enumerated by the Trustees. However, the Advisory Board will have only recommendatory powers and shall always abide by the decision of the Trustees and shall at no stage super-cede the directions of the Trustees.

7. TERM OF TRUSTEES:

15. DISSOLUTION:

All the Bank Accounts shall be operated by at least two trustees or any other person who has been specifically authorized in this behalf by them.
